APA Format and Documentation Handout

The handout hyperlinked above was created by Appalachian State University's Writing Center and describes the guidelines for the new 7th edition of the *APA Publication Manual*. Specifically, the handout goes over formatting, style and mechanics, and how to properly cite sources. The items in red identify the specific changes made from the 6th edition of APA.

APA Student Paper Template

This is a template that provides the basic structure of a student paper that meets the APA 7th edition guidelines. Like the sample student paper, this includes a title page, abstract, body that includes subtitles, and a reference page but provides instruction and allows students using the resource to fill in the blanks.
